



- **Purpose:** to advance the state-of-the-art of drilling wells by providing a forum for the sharing of knowledge through technical presentations on subjects/topics in line with the theme of each quarterly meeting. The DEA(e) also promotes the presentation of proposals for drilling-related JIPs for participation by members & non-members alike and advises academic organisations & other drilling oriented groups on the needs & interests of the members. The DEA(e) is a non-profit organisation.
- **Representation:** Each member organisation nominates one attendee for each meeting. Additional participants are placed on a waitlist which is opened at least two weeks before the meeting. Presenters from member companies get automatic registration, in addition to the nominated attendee.
- **Meeting:** A total of 4 DEA(e) meetings are held in the year – all in Europe.
